**REGISTRATION FEE**- \$250 per child (due upon enrolling) Infants- \$600.00 deposit (\$350 goes towards first month's tuition)

**Fall Hold/ANNUAL SUPPLY FEE**- \$300 per child due May 1<sup>st</sup>. Prorated at \$25/month.

**SIBLINGS RECEIVE A 5% DISCOUNT**- Applied to oldest child

Unless otherwise arranged, all childcare fees and tuition payments are due on the 1<sup>st</sup> if paid monthly, or the 1<sup>st</sup> and 15<sup>th</sup> if paid biweekly by ACH or cash. A late charge of **\$25.00/day** will be added to accounts not paid by these dates. Accounts past due over 2 weeks are subject to your child's withdrawal from North Tacoma Montessori Center. Tuition **MUST** be current for your child to go on field trips. A tuition agreement must be signed and filed with your child's Registration Form. Tuition is not discounted due to pandemics, acts of God, inclement weather or holidays/breaks/in-service staff training. All closures are listed at [www.ntmontessori.com](http://www.ntmontessori.com). NTMC is closed the week before Labor Day and the week between Christmas and New Year's Day.

**Part time families are exempt from all discounts and vacations.** Part Time schedules are 3 set days a week and will not be credited or substituted for absences.

A written 30-day notice must be given to withdraw your child.

Families are given 1-week vacation/year after a year of being enrolled at NTMC full time.

**RATES ARE EFFECTIVE BEGINNING Sept 1<sup>st</sup>, 2025**

**Our Hours are 6:30 AM-5:30PM with a 10-hour maximum/day. Pickups after 5:30 PM will be assessed a \$50 late**

fee. Three late pickups may be the cause for disenrollment.
